

## **Internal Complaints Procedure - Sales**

Should you feel dissatisfied with our service and wish to make a complaint, can we please ask you to follow the process below and we will respond to you in accordance with the timeframes as set out below.

### **Professional Membership details**

Goldschmidt & Howland are members of The Property Ombudsman and Propertymark. By belonging to these organisations, we are required to follow strict professional standards.

### **Stage One: COO - Sales**

We would kindly request that you initially make your complaint in writing to the COO - Sales.

When we receive your complaint, we will send you a written acknowledgement within three working days.

Our COO – Sales will then collate as much information as possible and liaise with the various departments involved to establish all the facts. Our COO – Sales will then send a written response to your complaint within fourteen calendar days.

We aim to resolve all complaints during this initial stage, however, if you are still not satisfied, we ask that you progress your complaint as follows.

### **Stage Two: CEO**

If you wish to progress your complaint beyond the COO - Sales, you may do so by writing to our CEO. On receipt of your complaint, the CEO will acknowledge your correspondence within three working days. Our final viewpoint will then be issued to you within fourteen calendar days.
